The SEFI Annual Conference is Europe's largest academic event dedicated to Higher Engineering Education. The 54th SEFI 2026 Annual Conference, which will be hosted by the Czech Technical University (CTU) in Prague, Czechia, from 7 to 10 September 2026. It will focus on the theme Engineering Education for Humanity. The conference is expected to attract approximately 600 participants from across Europe and beyond, providing an opportunity to explore the critical role of engineers in addressing societal challenges and shaping the future of education and technology. The conference venue, University Campus of CTU, is located near the Old Town of Prague, a UNESCO World Heritage site. And the CTU has been helping to write the history of Prague since 1707, when it began educating students in engineering disciplines.

The event will host approximately 600 leaders in engineering education, vice-presidents, deans, researchers, and educators from across Europe and beyond, to engage in discussions on the evolving role of engineers in addressing societal challenges and shaping the future of education and technology. Through keynote speeches, panel discussions, and interactive workshops, participants will explore innovative strategies to integrate societal needs into engineering practices and education, fostering a more sustainable future.

CANCELLATION POLICY

Cancellation Policy and Payment Terms

Reservation of sponsor and exhibition opportunities is binding. By submitting the sponsorship/exhibition application form, the Sponsor agrees to pay the total amount in full.

The Sponsor undertakes to provide the contribution in the total amount as follows:

First installment	50 % of the total value of the purchase order is due within 15 days from receipt of the invoice
Second installment	50 % of the total value of the purchase order is due by an individual date, according to the date of issue of the order/invoice

All cancellations must be submitted in writing to sponsoring@guarant.cz.

Cancellation fees applicable if the Sponsor cancels:

Cancellation within 7 days from receiving the invoice	cancellation fee of 50 % of the total Contract value
Cancellation after individual date on the order form, according to the date of issue of the order/invoice	cancellation fee of 100 % of the total Contract value

Except for the above cases, sponsorship fees are generally non-refundable.

The Organizer reserves the right to cancel or reschedule the event at its sole discretion. In the event of cancellation by the Organizer, the sponsorship fee shall be refunded in full. However, bank service charges and administrative fees will be deducted from the refunded amount. In the case of postponement, the sponsorship will automatically transfer to the new event date.

The Supplier is a VAT payer. VAT will be applied in accordance with the applicable legislation.
